# Why AAUW and Public Policy Matter

Persistent barriers within our country continue to hold women and girls back. AAUW works to remove those barriers through our Public Policy Priorities, which are member-driven and approved. These four priorities are the guidelines that inform, promote, enhance, and ensure security, justice, access, and representation for women and girls.

**PRIORITY**: Economic Security for ALL WOMEN including: equity in the work-place, enforcement of workplace anti-discrimination statutes, security in retirement, job training for career development and work-life balance.

**PRIORITY**: SOCIAL and RACIAL JUSTICE for ALL MEMBERS OF SOCIETY including: self-determination in healthcare decisions. Equal access to affordable healthcare and housing. Equal access to gender affirming care. Civil and voting rights protections. Protections for historically marginalized groups, and efforts to resist anti-immigrant policies.

**PRIORITY**: EQUAL ACCESS to QUALITY PUBLIC EDUCATION for ALL STUDENTS including: Title IX enforcement, adequate and equitable funding for public education. Historically accurate curricula. Civics instruction in all CA high schools, Equitable access to STEM programs. Funding to support strong infrastructure.

**PRIORITY**: INCREASED REPRESENTATION of WOMEN in LEADERSHIP ROLES including: Proportional appointment to publicly held boards. Leadership skills training. Programs that promote participation in public service.



# August Report From Your Board

#### July Action Items:

- · After a lengthy discussion regarding Intern Shanvi Gupta's book box and financial literacy projects, the board approved the financial literacy project, aligning it with the start of the school year. They also approved the Once Upon a Book Box project to be part of the endof-the-year financial literacy program.
- A new color printer was purchased on sale to bring the cost of color printing down to a reasonable level.
- Judy researched charitable gift annuities by contacting Silicon Valley Community Foundation. She learned that the amount of donor's contribution must be at least \$25,000 cash or stock. This financial vehicle could work well for older members because the money would be received by the charity at death. Younger members considering this vehicle could give income generated by their annuity to the Foundation to fund scholarships consistently.

**Finance:** The FY25 end of year financial report was audited and passed by Judy.

Unpacking "Equity" and "Equality"



- •A statewide book club, based on the book *The Four Pivots*, will get underway in September. The club will be headed by Charmen Goehring, AAUW-CA state president.



## RMDs and Charity

Want to lower your tax bill and give to donate to charity?

If you are over the ripe old age of 72, you must take a distribution from your traditional IRA or 403B. This is called a Required Minimum Distribution (RMD).

Rather than having your distribution come directly to you and having to pay taxes on this distribution and then giving to charity with your after-tax dollars, you can give to charity directly from your IRA or 403B.

What are the advantages? The money from your RMD to charity would be considered part of your RMD for that year. Because the money does not come to you but to the charity, it does not become part of your taxable income. And because it is not part of your taxable income, it may keep your Medicare premium lower.

Also, if you itemize on your taxes, certain items such as medical expenses, which only allow amounts of more than 7.5% of your adjustable gross income (AGI), can be greater because your income is lower.

Check this out with your tax consultant.

#### **Wolf Eats Crow**

I mentioned in a previous article that if you funded a charitable gift annuity, the charity would get an immediate gift. I was wrong. The charity does not get a gift from the charitable gift annuity source until you pass away. What goes on the 1099R you receive is the amount you can put on your schedule A as a charitable donation--not an immediate amount to the charity.

Do I still think charitable gift annuities are a good thing? You bet I do! My money flows to the bank every quarter.

## Interview With Senator Wahab Representative

Hi everyone! Thank you so much for coming back and taking the time to read my column again! I really do appreciate it, and I hope you enjoyed reading about my interview with Linda Leu of the TCV Food Bank! During July, I also had the pleasure of interviewing Barbara Ledesma Rhinehalt, a district representative for Dr. Aisha Wahab, state senator. **Shanvi**: You said that district representatives have the opportunity to really focus on one thing. Is that a requirement for everyone as a district representative, or could you just choose to be general?

**Barbara**: It's not a requirement. It works well for a team because we end up with natural trade-offs, but if someone really wants to be broad, our team is also receptive to that. I've been with the team for over a year now, so my first six months were "I want to look at everything and find my niche through a little bit of work."

**Shanvi**: What exactly led you to join public services, and specifically Senator Wahab's team?

Barbara: In undergraduate studies, I studied political science and urban city planning, and my intention was to work in public service much more at the bureaucratic level; I wanted to work in the city and planning department. That ended up not being as fulfilling to me, because I'm a very outgoing person, so I was very fortunate to be able to work in the transportation center in a public-facing capacity. In the general public service aspect, my family was very involved in public service, and I grew up in a very small area so it was very easy to get connected and engaged. When I was choosing my major, I was reflecting on everything I had done in high school, and I saw what I was doing was very similar to what I would want city/government people to be doing. Those experiences led to me being open to work in a government office, and for Senator Wahab's office particularly. (At the time) The office was running a significant transportation bill and so I was able to speak to that bill and give a little more support towards that.

**Shanvi**: Ahh, okay! Well, thank you so much for answering my questions, this was very inspiring and I really appreciate it!




